Plan for In-Person Instruction and Continuity of Services

The COVID-19 pandemic has created major upheaval to all aspects of life, including unprecedented school closures in the spring of 2020. The Panhandle School District reopened schools for in-person instruction in the fall of 2020 and followed the required strict health and safety protocols required for in person learning during the 2020-2021 school year. These protocols created barriers and limitations to teaching and learning as well as significant challenges for students, staff, and families in Panhandle CUSD 2.

Taking the local interests and needs input into account, this plan was also developed through meaningful consultation with a collaborative of students, parents, school and district administrators (including special education administrators), teachers, school staff, food service staff, transportation service staff, labor association leaders, and county health department officials. Opportunity for the public to provide input was provided from February 22-28, 2022. This plan will also be made publicly available on the district's website. School strategies in this plan may be removed based upon local conditions, levels of community transmission (i.e., low, moderate, substantial, or high), local vaccine coverage, use of screening testing to detect cases in K-12 schools, and consultation with local public health officials to determine the prevention strategies needed. School officials will communicate any changes in plans to staff members, students, and parents through the district's regular communication platforms.

Maintaining the Health and Safety of Students, Educators, and Other Staff

In accordance with the Illinois State Superintendent of Schools July 9, 2021 declaration, the Panhandle School District will be open fully for in-person learning for all student attendance days for the 2021-22 school year. Remote instruction who are under quarantine as directed by the local health department or the Illinois Department of Public Health. These guidelines include the following:

Phase Implementation

- The Panhandle School District will continue to implement phased mitigation strategies to maintain a safe in-person and continuity of services within the school district which began to occur during the 2020-2021 school year.

Mask Use

- Mask use is recommended indoors for students, staff and visitors who are not fully vaccinated. Mask use is recommended outdoors during activities (e.g., participating in outdoor play, recess, physical education, sports, extra curriculars) that involve sustained close contact with other people who are not fully vaccinated, particularly in areas of substantial to high transmission.
- Based on the current conditions in our communities, the Panhandle School District has implemented a mask optional policy.
- School staff are to model support for and encourage students to be supportive of people who continue to wear a mask as a personal choice or because of a personal medical reason.
- Mask Signage will be posted within school buildings and on school buses.
- Unless exempt by CDC Order, passengers and drivers must wear a mask on school buses.
- A driver does not need to wear a mask if they are the only person on the bus.
- We will continue to monitor the health and wellbeing of our students and staff and adjust accordingly if needed. Everyone, students and staff, should be prepared to wear masks if local (county, region, and/or district) metrics warrant that need during the course of the school year.



Physical Distancing

- To the extent possible within school and classroom structures so that it does not exclude students from full day in-person learning, school staff are to help students commit to physical distancing as much as possible by:
 - arranging furniture, play spaces and reinforce physical distancing of at least 3 feet and movement;
 - providing assigned seating for students and encourage students to remain in these seats to the greatest extent possible; and
 - monitoring paths of travel in classrooms and corridors.
- School staff will maximize physical distance as much as possible when moving through food service lines and while eating indoors.
- Physical distancing measures are to be done in an equitable manner that does not perpetuate academic, racial, or other tracking (e.g., separating people into fully vaccinated and non-fully vaccinated cohorts).

Handwashing and Respiratory Etiquette

- School staff will monitor and reinforce frequent handwashing and respiratory etiquette by
 - continuing to teach handwashing with soap and water for at least 20 seconds;
 - assisting young children with handwashing;
 - reminding everyone in the facility to wash hands frequently.
 - using hand sanitizer containing at least 60% alcohol (for teachers, staff, and older students who can safely use hand sanitizer) when handwashing is not possible;
 - continuing to teach respiratory etiquette (e.g., covering coughs and sneezes); and
 - providing adequate handwashing and hand sanitizer supplies that are safely stored (up, away, and out of sight of young children and used only with adult supervision for children under 6 years of age).

Facility and Transportation Cleaning, Disinfection and Ventilation

- School custodial staff and transportation staff will continue to clean surfaces daily. To further reduce the risk of spreading infection, these staff will also use disinfectants on the U.S. Environmental Protection Agency COVID-19 “List N” to disinfect spaces occupied by someone who tested positive for COVID-19 within the last 24 hours.
- Maintenance staff will continue to regularly replace school ventilation system filters by using high-efficiency particulate air (HEPA) filters.
- When possible, staff will open doors and windows, when circumstances allow.
- When it does not pose a safety risk, transportation staff will keep vehicle windows open at least a few inches to improve air circulation.

Food Service

- Social distancing will be maintained in all school areas to the greatest extent feasible.
- Cafeterias will continue to undergo increased cleaning/sanitation.
- Student meals will be free for the 2021-2022 school year in accordance with USDA reimbursements.



- Breakfast will be served within the cafeterias 7:30-8:05am each school day.
- Lunches will be served within the cafeterias during designated lunch periods.
- Water bottle filling stations will be available within the school district. Water fountains will not be used unless the station also has a connected filling station.

Contact Tracing

- Students and staff who have symptoms of infectious illness, such as influenza (flu) or COVID-19, should stay home and contact their healthcare provider for testing and care.
- Individuals in our school environments who show symptoms of COVID-19 are to immediately report to the nurse's office
- Student absences related to a COVID-19 will be recorded as excused. To ensure continuity of services, schoolwork missed during such an absence can be requested and made up in accordance with the school's policy (refer to student handbook); social, emotional, mental health, or other needs will be provided in accordance with a student's IEP or 504 Plan. Parents of students who have social, emotional, mental health, or other needs outside of an IEP or 504 Plan should contact their child's principal to discuss needs. A remote instruction will only be made available for non-vaccinated or vaccine ineligible students who are under quarantine as directed by the local health department or the Illinois Department of Public Health.
- Staff absences related to a COVID-19 isolation or quarantine will be recorded in accordance with the district's sick leave policy and related professional negotiations agreements. To ensure continuity of services, staff members should contact their principals to discuss support for social, emotional, mental health, or other needs.
- To the extent allowable by privacy laws and other applicable laws, school health care professionals will continue to collaborate with Montgomery County Health Department officials to confidentially provide information about people diagnosed with or exposed to COVID-19, including making notifications to staff and parents as soon as possible regarding those who were in close contact of someone in the school who tested positive for COVID-19.
- Traditional contact tracing for positive cases and Test to Stay protocols will be adjusted to meet the needs present within the school building. If you would like your child to be tested because of a known exposure or if your child is symptomatic, we will still be able to test. The following are possible scenarios and how they will be handled:
 - Students and staff who have an illness, fever, or other health symptoms should stay home and contact their healthcare provider as necessary. Students should be fever free for 24 hours before returning to school after an illness.
 - You can call the nurse and request a test to be done if you would like, otherwise stay home until fever free for 24 hours and/or symptoms are improving.
 - COVID-19 Rapid testing is available through the school nurse for family's who wish to have their child tested.
 - All other illnesses are still under the same protocols as pre-COVID times. Examples:
 - Strep Throat- on antibiotics for 24 hours/fever free 24 hours
 - Pinkeye- on eyedrops 24 hour
 - Vomiting/Diarrhea- free from v/d for 24 hours



Screening

- Parents should keep their children home from school if they are sick or exhibiting symptoms.
- You can call the nurse and request a test to be done if you would like, otherwise stay home until fever free for 24 hours and/or symptoms are improving.
- COVID-19 Rapid testing is available through the school nurse for family's who wish to have their child tested.

Promoting Vaccination

- Respectful of peoples' varying levels of vaccine confidence, those who want to get vaccinated against COVID-19 can visit [vaccines.gov](https://www.vaccines.gov) to find out where they can get vaccinated in our community.

Disabilities or Other Health Care Needs

- Parents of students who need accommodations, modifications, or assistance related to COVID-19 safety protocols, disabilities, underlying medical conditions, or weakened immune systems should contact their student's case manager to discuss the need(s).
- Staff members who need accommodations, modifications, or assistance related to COVID-19 safety protocols, disabilities, underlying medical conditions, weakened immune systems, or a sincerely held religious belief or practice (covered by Title VII of the Civil Rights Act of 1964) should contact their school's principal to discuss the need(s). Staff members with weakened immune systems are advised to contact their healthcare professional about the need for continued personal protective measures after vaccination.

Visitors

- Nonessential visitors, volunteers, and activities involving external groups or organizations are discouraged from visiting schools during the school day.
- Athletic programs will run as normal with full activity fees charged and admission charged at indoor, home sporting events.

Schools and Students

- School will be in session five days a week and the regular school day will be 8:05am to 3:00pm.
- The district will be prepared to adjust educational and athletic programming as necessary throughout the year.
- Students will be issued individual devices. Students in 6-12th grade will be able to take their devices home when directed by school staff.
- Field trips and fundraisers will resume as normal.
- Locker rooms will be utilized for PE and students in 6th-12th grades will wear required PE uniforms.
- Student lockers will be utilized at Lincolnwood.

Collaboration with Public Health Officials

- District officials will continue to collaborate and consult with Montgomery County Health Department officials throughout a pandemic on various logistics and plan decisions

Plan Review



- Through September 30, 2023, this plan will be reviewed no less frequently than every six months and revised as appropriate after seeking and considering public input. Revisions will address the most recently updated safety recommendations by the CDC, provided in an alternative format accessible to parents who are individuals with a disability as defined by the ADA, and made publicly available on the district's website.
